

Rules and procedures are changing for drivers and vehicles operating in Europe. This will result in operational changes, but there are actions you can take today to remain compliant in January:

Declarations



- Customs declarations and safety and security declarations will be needed. Customs declarations will be required for both import and export. For many hauliers, the best way to remain compliant will be to work with a customs broker or intermediary. Safety and Security declarations will be the responsibility of the haulier from 1 January. Our service allows hauliers to manage all of their declarations in one place.

 - Appoint a broker to help you deal with your customs and safety and security declarations.

Driver



- International Driver Permits (IDP) may be needed from 1 January.
- Passport with 6 months validity left on it will be needed by drivers traveling into Europe.
- Awareness of new procedures. You will need to ensure your drivers are aware of what they need to do under the new border regulations.
 - Sign up to our service and updates and we will give you all you need to carry out this training in house.

Vehicle



- Insurance green cards will be needed to prove that your vehicle is insured abroad.
- All vehicles will need to display a separate GB sticker to travel.
 - Compliant GB stickers will be provided to all hauliers who sign up to the RHA Customs Brokerage service before 10 December.

Operations



- Operator Licencing UK Operators undertaking international work will continue to need the relevant operator licences or permits.
- Pallets You will need to ensure that your pallets are ISPM 15 standard and are stamped accordingly.
- Routing You may need to route your vehicles differently
 to avoid transiting through European countries or to use
 specific customs or border control points in GB. This may
 require an overhaul of your route planning as this will
 impact your drivers' hours.
- **Incoterms** Haulier can now be responsible for these and this may impact your operations.
- **UK EORI Number** You need to register for a UK EORI Number as these will be required after 1 January. You can apply here: **www.gov.uk/eori**
- EU EORI Number You will also need an EU EORI Number, you can apply for this once you have a UK EORI Number. You can apply here: https://ec.europa.eu/taxation_ customs/business/customs-p.

Talk to your customers



- Do they understand what information they need to give you before you move their goods?
- There are up to 30 pieces of information, all of which you may need to generate a customs declaration and move goods.
